Encyclopedia Dialectica's New, Higher Standard of Scientific Empiricism

<u>Author's Preface</u>. The purpose of this third Vignette in the $F.\underline{E}.\underline{D}$. Vignettes series is to make public, for the first time, one of the key, higher-scientific principles that have guided the research efforts of *the Seldon Project* since its inception. In this case, that principle is '*The Principle of Chrono-Empiricism*'.

Background. The **Encyclopedia Dialectica** [**E**.**D**.] 'Dialectical Theory of Everything' -- our theory of the Universe/maximal Totality -- and the **E**.**D**. 'sub-theories' of this Universe's 'sub-universes', are all suffused with a pervasive '*Principle of Irrepeatability*'. This principle may be formulated as follows: 'Absolute, exact 're-petition' of events / actions -- or absolutely "circular" 'cyclicality' -- is impossible, because any 'second -petition' must occur in an environment already altered by -- already partly the result of -- 'first -petition', and so the consequences of 'second -petition' must, in part, be different from the consequences of 'first -petition'.'

This principle holds that there exists, for this Universe, an ineluctably <u>cumulative</u> aspect to all physical existence/action/process: 'Entities/events/''eventities'' cannot be purely "circular" or "cyclical", but must always exhibit some measurable degree of ''spirality'' or ''helicity'''.' This '*Principle of Irrepeatability*', stated above by way of the 'negatory' or 'denialatory' term '<u>ir</u>-repeatability', can also be re-stated via a 'posit-ory' or 'affirmatory' *term*: '*Distinct* '''*eventities*''', <u>as such</u>, may be <u>similar</u> to one another, but they <u>cannot be</u> <u>identical</u> to one another.'

This *'Principle of Similarity*' means that any "two" "'eventities'" in the Universe -- i.e., if they are really "two", not really just "one" -- logically cannot be "one" in the sense of being "*identical*" -- entirely the same -- since, at absolute minimum, they are different by virtue of occurring in / at different positions in / of space /- time / space-time.

This principle is thus one which *affirms <u>similarity</u>*, but *denies '<u>identicality</u>'*, as a relation which can prevail between "different" «*monads*», or *units*, of the same «*arithmos*». This principle is also one which *denies* the entire '*Principle of Identicality*' which is implicit, and endemic, in much of that part of today's scientific reasoning which is vitiated by '*The Modern Ideology*'.

Vignette #3, Chrono-Empiricism

This '*Principle of Similarity*' applies even to the supposed "*quanta*", or "*quantum particles*", of linear Schrödinger Equation "Quantum Mechanics". E.g., any "two" «*monads*» of the cosmological "photons" «*arithmos*»; any "two" «*monads*» of the cosmological "electrons" «*arithmos*», although each pair, respectively, is universally in a mutual relation of '*``similarity*''', can never be universally in a mutual relation of "*identicality*"; can never be entirely the same and indistinguishable: to be "two", "different", "distinct", "particles", they will have to have *different* histories of *interaction*, i.e., *different* histories of "*quantum entanglement*", different [e.g., non-local] "*correlations*".

Seen in a larger, more *gene*ral context, the universal '*Principle of Irrepeatability*' / '*Principle of <u>Non</u>-<i>Identicality*' / '*Principle of Similarity*' is a «*species*» of the <u>*E*</u>.<u>*D*</u>. universal '*Principle of Meta*-<u>*Fractality*</u>'.

The usual mathematical concept of a *'fractal'* envisions a static, synchronic, 'spatial' [e.g., **2-D** "geometrical"], hyper-idealized self-similarity structure, with an *"actually infinite"* regress of ever-diminishing size-scales -- e.g., of length-scales, of area-scales, of volume-scales, etc.

The <u>*E</u>.<u></u><i>D*. concept of '*meta-fractality*' encompasses also realistic, actually-observed, or actually-constructible, including '*meta-finite*' similarity regresses.</u>

These include synchronic-slice similarity regresses with '*qual*itative scaling' [in terms of *qual*itative determinatenesses] -- '*qualo-fractals*' -- as well as with ''*quant*itative scaling'' [thus, taken as a whole, as a '''unity''', with '*qualo-quant*itative scaling'].

They also include «*species*» of *dia*chronic, *chrono*logical, "*long*itudinal" '*meta-fractals*' in which '''*temporal acceleration*''' is an aspect of '*qualo-quanto-fractal* diachronic scaling', as well as synchronic, diachronic, and '*diachronico-synchronic*' sub-«*species*» of the «*species*» of '*qualo-quanto-fractals*', for which the scaling 'moment' of the «*genos*» of '*meta-fractality*' is relaxed, at least in regard to *quant* to *quant*.

"size" [e.g., in terms of the $\underline{\mu}$ dimensional-dialectical arithmetic, to the $|V| = |L|^{+3} = \text{cm}^{+3} = \overset{\circ}{\underline{\mu}}_{+3} \overset{\circ}{\underline{\mu}}_{3}$

dimensional *unit* / '*metrical unit-qualifier*']. For example, an adult human person is *self-similar*, *rather than self-identical*, *through time*, not exhibiting much size-scaling [post-adulthood; post-maturity/post-majority].

The 'ontological-categorial progressions' generated by <u>E</u>.<u>D</u>. Dyadic Seldon Function dialectical 'meta-models' of 'physio-onto-dynamics' generally both instantiate, and model, 'diachronico-synchronic', temporal-acceleration-exhibiting, 'meta-finite meta-fractals', in the form of 'qualo-quanto-fractals'.

The '*meta-finite*' character of all of these '*meta-fractal*' «*species*» -- meaning that they may encompass *qual*itative, *ontological* change/expansion between their pairs of scales, but that their scale-regresses *remain finite* in scales-count -- is in alignment with <u>*E*</u>.<u>*D*</u>.'s '*Principle of Metafinity*', which asserts that '*Infinity is non-actual*.', i.e., that '*Infinities are empirically unmanifest in this universe*.'

The *gene*ric '*Principle of Irrepeatability*' has a *speci*fic corollary, the '*Principle of Historical* <u>Ir</u>-reversibility'. That is, not only is it impossible to exactly repeat '''*eventities*''' in the forward sense of time, relative to past-occurring '''*eventities*''', but, likewise, it is impossible to "*run time in reverse*": to exactly repeat past '''event[itie]s''' in reverse chronological order.

Unfortunately, "*time reversibility symmetry*" is a *contra-experiential*, <u>non</u>-objective, contra-empirical, and therefore '*contra-scientific*' feature exhibited by many of the supposedly reality-modeling equations of Standard modern Physics.

If a model of a deterministic process, or dynamic, is *time reversible*, then the *time-reversed*, *'ana-chronic'*, *'anti-temporal'* process -- as [*falsely*] modeled by that model -- *satisfies the same model equation* as the true, *'pro*-verse', *'pro*-time', *'pro*-chronological', *actually-observed* process. This model-behavior constitutes a form of model-equations <u>un</u>realism, or *'homeomorphic defect'*, also known as *"time-reversible dynamics"*. <u>Vignette #3</u>, *Chrono-Empiricism* #3 -- 2 by A. Dyosphainthos of Foundation <u>Encyclopedia Dialectica</u> [F.<u>E.D.</u>] "*Time reversible dynamics*" means, in general, that the model equations are "symmetric" -- "invariant" -- under a change in the sign of \mathbf{t} -- the "<u>time variable</u>", as "universal independent variable" -- from +**t** to -**t**.

The model-equations of classical mechanics, for example, and of classical optics, are "*time-reversible*". Contemporary Quantum Mechanics is not quite "*time-reversible*", exhibiting, instead, a richer symmetry, called "<u>C</u>harge-<u>P</u>arity-<u>T</u>ime Symmetry", or "CPT Symmetry", for short -- a symmetry which is deeply-related to Lorentz Invariance [cf., for example, *Wikipedia* entries on "Time reversibility" and "CPT symmetry" --

When an <u>Encyclopedia Dialectica</u> 'dialectical definition-equation', which constitutes that encyclopedia's definition for a given dialectical '*nature*-al' progression, is supplied with a negative temporal argument -- a minus-signed parameter-value, such as the value $\tau = -1$ -- for <u>E.D</u>.'s <u>NQ</u> dialectical 'meta-model' of the '''*meta-evolution*''' of the *cosmological totality* --

-- this means that the «*arché*» of that progression, in this case $\frac{1}{2}$, denoting that *primordial* cosmological «*arithmos*» which has sub-<u>n</u>uclear "particles" as its «*monads*», is "raised" to the "power" $2^{-1} = 1/2$, i.e., that taking the "square-root" of the «*arché*» <u>q</u>ualifier, $\frac{1}{2}$, $\frac{1}{2}$, is indicated. The resulting generic equation --

-- constitutes an <u>un</u>solvable equation within the "Gödelian incompleteness" of the axioms-system of the \underline{NQ} dialectical arithmetic [for any version thereof which uses an "*evolute*" product rule for its Axiom §9; only the *meta-heterosis <u>convolute</u> product rule* would render square-root taking possible in its version of \underline{NQ} , but still <u>not</u> in this case; still <u>not</u> in the case of the *«arché*», $\underline{E} \rightarrow \underline{T}$].

Square roots <u>can</u> be meaningfully taken for <u>NQ</u> <u>un</u> interpreted, generic arithmetical values, and for *interpreted*, applied, algebraic values, e.g., for/of the 'multi-**g** ualifier cumula' that result from $\tau > 0$ values of such *Dyadic* Seldon Function dialectical 'meta-models'. They yield their immediate-predecessor epoch's cumulum as the value of their square-root, e.g. --

However, such values do <u>not</u> arise for *any* minus-signed value of a $\tau \in \mathbb{Z}$ epoch-parameter / temporal independent variable of a Dyadic Seldon Function.

Instead, the epochal-time values $\tau = -2$, $\tau = -3$, $\tau = -4$, etc., result, respectively, in the $(1/4)^{\text{th}}$ power (or the 4^{th} root) of the *«arché»* **g**ualifier, in the $(1/8)^{\text{th}}$ power (or 8^{th} root) of the *«arché»* **g**ualifier, and in the $(1/16)^{\text{th}}$ power (or 16^{th} root) of the *«arché»* **g**ualifier, etc., which are, again, values which do <u>not</u> exist in the NQ number-space. Therefore, *Dyadic Seldon Function*, dialectical 'meta-model' equations written in the language of the <u>NQ</u> dialectical ideography, do not support the *"time reversibility symmetry*" which compromises the scientific, empirical fitness of so many of the "natural law" equations of Standard modern Physics.

Vignette #3, Chrono-Empiricism

<u>Definition</u>. The meaning(s) of the term '<u>chrono-empiricism</u>' is (are) also known, within **F**.<u>*E*.</u><u>*D*</u>., by the 'syno-names' 'time-empiricism', 'temporal empiricism', and 'historical empiricism'.

These words / phrases name the new, higher standard of scientific empiricism offered by <u>*E*</u>.<u>*D*</u>., as an included moment of its Marxian paradigm of '*psychohistorical materialism*'.

That paradigm centrally includes the view that the human phenome, human memes, human "ideas" in general, are "idea-<u>matter</u>" -- that they are "<u>material</u>", *inter-subjectively objective*, and *causative* moments in the social self-production and self-*re*-production of human societies; in the self-production of human [<u>psycho]history</u>, and in the historical interaction of the planetary[**()**] patch of 'human[-ized] nature'; of 'humanity's laborious self-objectification in nature', enveloped, from without and from within, by environing extra-human nature.

The principle of '**<u>Chrono-empiricism</u>**' holds that scientific theories that abstract from natural history; that embody only '*natural-historical <u>gene</u>ricity*'; that fail the test of ''*natural-historical <u>speci</u>ficity*''' [cf. Marx]; that offer only ''*supra-historical*''' *categories*, or '*meta-temporal summarizations*', and which exhibit the ''*time reversibility symmetry*'', e.g., in their mathematical models, represent an insufficient degree of fitness to the *historical content* -- to the *temporal ordinality content* -- of the scientific, empirical data of objective nature. In short, such models *fail to fit the temporal data of nature*.

An example of a mathematical model exhibiting the "'supra-historical'", 'historically abstract' -- *abstracting from natural history* -- 'meta-temporal summarization' characteristic is the "black body" <u>Temperature/Radius</u> /- <u>L</u>uminosity relation, asserted as an approximate "model" of stellar evolution: $L = 4\pi R^2 \sigma T^4$. As presented, this mathematical, purely-quantitative relation represents a <u>*dis*</u>-ordered -- 'de-ordinalized', 'de-temporalized', and 'de-historicized -- essentially *random set* of <u>L</u>uminosity values, some of which may arise for combinations of <u>R</u>adius and <u>T</u>emperature values actually encountered in the historical self-development of various classes of stars, but providing no indication as to which {<L, R, T>} values those are, or in what temporal-ordinal -- historical -- sequence those values actually occur per empirical observation/reconstruction. A partial fixing of such sub-empirical historical abstractness might be by a model L(c,m,t) = $4\pi R(c,m,t)^2 \sigma T(c,m,t)^4$, which *modeled the actual timed trajectory* of the L(c,m,t) "dependent variable" as a function of those of the **R(c,m,t)** and **T(c,m,t)** "independent variables", with all three being functions of <u>t</u>ime, of stellar <u>mass</u> [including of *birth*-mass], and of stellar <u>c</u>omposition [including of *birth*-composition], i.e., in terms of star type/class/«*species*».

That is, this principle holds that truly scientific theories must, as part of their most central explanatory content, *"reproduce the temporal data"* of the actual historical *"order of appearance"* [cf. Chardin] of the different *«gene»* and *«species»*, etc., of *«monads»* that constitute the multiple 'physio-ontological', and/or 'ideo-ontological', categories, or *«arithmoi»* -- the *'kinds* of *"numbers*" [of *«monads»/units*] -- that they invoke, as this *order of emergence* is reconstructed, from the data effectively "materially recorded", in human *"*'historical *present*-presents"', by/from *"*'historical *past*-presents"', human and pre-human.

The <u>E.D.</u> principle of '<u>chrono-empiricism</u>' holds that scientific theories must model and explain the <u>necessary</u> ''temporal ordinality''', or ''historical logic''' – the ''what follows from what, and why''' – of the ['<u>qualo-Peanic'</u>] sequence, or 'consecuum' -- of the succession and, more accurately, of the dialectical progression -- of events, of ''eventities''', of '<u>kinds</u> of being/becoming', that constitute objective, empirical nature as inherently temporal, as inherently dynamical, as 'nature-al <u>history</u>': that constitute the very empirical content of '''concrete duration''' [cf. Bergson]; of concrete '''time''''.

<u>Illustrations</u>. Thus, the <u>E.D.</u> <u>Dialectical</u> Theory of Everything Equation', $\frac{1}{\sqrt{-1}} - \langle \tau_{\downarrow\uparrow} \uparrow = \langle \psi^{\uparrow} \uparrow \rangle^{2^{\tau}}$

['pre-constructed'/predicted next epoch]: ${}^{3}_{h} {}^{6}_{\Psi} {}^{K} = {}^{3}_{h} {}^{\Psi} {}^{K} \longleftrightarrow$ Psychohistories, i.e., 'Meta-Sciences' $E \rightarrow {}^{T}_{16}; \dots$.

All of these '*meta-model*' dialectical equations of *Universe*, and/or of *sub-Universe*(*s*), ''*meta-evolution*''', are '''time-<u>ir</u>reversible''' -- are <u>un</u>solvable for negative values of their **t** epochal-time parameters / independent variables. They thus exhibit ''*time reversal asymmetry*''', or '*temporal directionality* / *relative anisotropy*'.

Hence they do <u>not</u> exhibit "time reversal symmetry", or support the contra-empirical, contra-scientific, 'modern-ideological' <u>defects</u> of "time reversibility", or other forms of neo-Parmenidean "'time-less-ness'".
